**OFFICIAL REBATE TERMS & CONDITIONS:** Purchasers in the United States will receive the rebate in US dollars in the form of a Visa® rebate card, to be mailed to the address provided on this Official Mail-in Rebate Form. Rebate card is issued by JP Morgan Chase pursuant to a license from Visa U.S.A. Inc. Card can be used at any merchants that accept Visa debit cards. Certain fees may apply with the use of your Visa card. Purchasers in Canada will receive the rebate in Canadian dollars in the form of a Rebate Check, to be mailed to the address provided on this Official Mail-in Rebate Form. Purchasers will receive a \$50 rebate by mail for the Cooper CS4 Touring Tires and a \$40 rebate by mail for the Cooper GFE Tires. **Limit one (1) rebate per four (4) qualifying tires purchased in a single transaction.** All sales receipts or invoices must be dated between 8/25/10 and 10/16/10. All rebate requests must be postmarked by 11/16/10 and received by 11/30/10. LATE SUBMISSIONS WILL NOT BE ACCEPTED. Names on invoice and rebate form must be identical. Please retain a copy of all documents submitted for your own records. Purchase (in a single transaction) four (4) new tires of the following qualifying Cooper tires: Cooper CS4 Touring and Cooper GFE.
